# HOLIDAY VISA C1 or 211A

## DESCRIPTION

- Carry out activities related to tourism, and visiting friends or family.
- This visa valid up to 180 days with 2 time extension
- The C1 is a single entry visa.
- You can travel all over Indonesia with this visa
- This visa does not allow to receive money in Indonesia or receive a salary

## PRICING

### OFFSHORE

(process time 14 working days)  
Sponsor Legal Legends: IDR 2,500,000

(process time 5 working days)  
Sponsor Legal Legends: IDR 4,000,000  
Own sponsor: IDR 3,500,000

### Extension:

IDR 1.900.000 / extension / 60 days (maximum 2 extensions).

\* to apply for visa extension, bring your original passport to one of our offices at least 10 working days before the visa expiration date



**STEP 1:**  
Submit all documents to LLI for checking



**STEP 2:**  
Invoice & Payment



**STEP 3:**  
Submit to Immigration



**STEP 4:**  
Wait for E-Visa to be issued



**STEP 5:**  
E-Visa issued. 90 days to enter Bali.



**STEP 6:**  
Extension to be done before the visa expires.

## APPLICANT REQUIREMENTS

- Photocopy of your passport (minimum 12 months)
- Last 3 bank statements in PDF format (minimum 2000 USD at the end of the month)
- Airline ticket (outbound, you do not need the return)
- Identity photo (selfie on a white background with a t-shirt)
- Address in Indonesia
- Mother name

Additional documents to provide for children:

Birth certificate (No need traduction)

## WHAT IS IMPORTANT TO KNOW

- This visa does not allow to receive money in Indonesia or receive a salary
- Please inform us of your travel or exit plans to extend your visa on time.
- The visa is single entry; leaving the territory cancels it.
- Extensions must be initiated 10 days before the visa expires
- It is possible to do only 60-days extensions.
- If you exceed the validity date of your visa, the penalty is IDR 1 million per day per person
- We can convert this visa into a KITAS only if the sponsor is Indonesia compagny
- Immigration reserves the right to change regulations at any time.

# **HOLIDAY VISA**

## **FREQUENTLY ASKED QUESTIONS**

### **1) CAN I APPLY FOR A HOLIDAY VISA WITH VOA?**

If you have a VOA, you can apply for a Holiday visa only while abroad, which means you must first leave Indonesia and then apply. You cannot combine the Holiday visa and the VOA.

### **2) WHEN SHOULD I REQUEST AN EXTENSION?**

We will remind you in advance, but remember that you must request the extension 10 working days before your visa expires.

### **3) WHAT IS THE PROCEDURE FOR THE EXTENSION?**

Bring your original passport to our office. We will apply for your visa extension. The process is maximum 7 working days. The immigration site may encounter problems and it is possible to have to make an appointment at the immigration. Our team will keep you informed

### **4) CAN I WORK WITH A HOLIDAY VISA?**

No. This visa does not allow you to work and earn money in Indonesia.

### **5) WHAT ARE THE DIFFERENCES BETWEEN BUSINESS, INTERNSHIP AND HOLIDAY VISAS?**

They are all very similar. All are given for 60 days and can be extended twice up to 180 days in total. Their main difference is the purpose of each visa:

Business Visa - for business meetings - sponsored by a company or LLI

Internship Visa - for unpaid internships - sponsored by a company

Vacation Visa - for a tourist visit sponsored by a travel agency or LLI

Legal Legends can provide sponsorship for all of them except for an Internship Visa

### **6) DO CHILDREN UNDER 18 NEED A VISA?**

Yes, children and babies need a visa to enter Indonesia.
