# BUSINESS VISA C-2

## DESCRIPTION

- For those who plan to stay in Indonesia for no more than 180 days.
- Business talks, business visits, investment visits.
- Can be extended or converted to any other Visa without leaving Indonesia.
- Single entry Visa. If you leave Indonesia, you will need to start the process for a new visa.

## PRICING

Process time 5 working days

### OFFSHORE

Sponsor Legal Legends: IDR 4,500,000  
Own sponsor: IDR 4,000,000

Extension:

IDR 2.750.000 / extension / 60 days  
(maximum 2 extensions).

\* to apply for visa extension, bring your original passport to one of our offices at least 7 working days before the visa expiration date

## APPLICANT REQUIREMENTS

- Copy Passport minimum validity of 12 months.
- Personal Bank Statement (last 3 months) with min USD 2.000
- Address in Indonesia
- Mom name
- Phone number and email address
- Arrival flight ticket

## OWN SPONSOR REQUIREMENTS

- The deed of the company / Akta
- SK Menkeh
- NIB
- Letterhead
- Stamp of the company (Physical stamp)
- Balinese ID card/ local KTP
- KTP/Passport Director
- SKTU
- NPWP of the company
- Username and password for visa online if they have it
- If they don't have, add Bank Statement of the company (Min 10.000 USD)



# BUSINESS VISA

## FREQUENTLY ASKED QUESTIONS

### 1) CAN I APPLY FOR A BUSINESS VISA WITH VOA?

If you have a VOA, you can apply for a Business visa only overseas, which means you must leave Indonesia first and then apply for a business visa.

### 2) WHEN SHOULD I REQUEST AN EXTENSION?

We will remind you in advance, but remember that you must request the extension 7 working days before your visa expires.

### 3) WHAT IS THE PROCEDURE FOR THE EXTENSION?

Bring your original passport to our office  
We will apply for your visa extension and schedule a fingerprint and photo submission at the immigration office (for the first extension)  
We will notify you of your visit to the immigration office by WhatsApp one day before  
After your visit to the immigration office, we will receive your passport and you can pick it up at our office

### 4) CAN I WORK WITH A BUSINESS VISA?

No. A business visa does not allow you to work and earn money in Indonesia.

### 5) WHAT ARE THE DIFFERENCES BETWEEN BUSINESS, INTERNSHIP AND HOLIDAY VISAS?

They are all very similar. All are given for 60 days and can be extended twice up to 180 days in total

Their main difference is the purpose of each visa:

Business Visa - for business meetings - sponsored by a company or LLI  
Internship Visa - for unpaid internships - sponsored by a company  
Vacation Visa - for a tourist visit sponsored by a travel agency or LLI

Legal Legends can provide sponsorship for all of them except for an Internship Visa

### 6) DO CHILDREN UNDER 18 NEED A VISA?

Yes, children and infants need a visa to enter Indonesia.

# DOCUMENTS DO'S & DONT'S

To avoid delay in your Visa Application, please apply the rules below to any documents you send to us.

## 1) SCAN YOUR DOCUMENT

(PASSPORT, ID CARD, FAMILY BOOK, BIRTH CERTIFICATE...)

ENSURE YOU SEND US A CLEAN AND READABLE SCAN OF YOUR DOCUMENT, DON'T JUST TAKE A PICTURE OF IT.



## 2) SEND A PDF DOCUMENT

(BANK STATEMENT, VACCINE CERTIFICATE, INSURANCE...)

PLEASE DON'T SEND SCREENSHOTS, BUT SEND A READABLE AND CLEAN PDF DOCUMENT.



## 3) TAKE ID PHOTO WITH WHITE/RED BACKGROUND

MAKE SURE IT IS A CLEAN, GOOD-QUALITY PHOTO WITH THE RIGHT COLORED BACKGROUND.
