DESCRIPTION

- Student KITAS is for those who are studying in Indonesia from Kinder garden to Senior Highschool
- The KITAS is valid for 5 years
- Each year the visa will need to be extended. There is no need to leave the country to arrange the yearly extensions.

PRICING

• Student e-Visa, e-KITAS, MERP 1 Year: 10.000.000 (process 2 months)

Annual Extension: IDR 10.000.000 (process 2 months)

Exit Permit Only (EPO):

IDR 1.000.000 (for cancellation of the KITAS)

STEP 5: Offshore can arrive to Indonesia. Process in Bali immigration to get the KITAS



STEP 6: KITAS is done

- Copy of Passport valid for at least 18 months
- Student's last report card

REKOM LETTER

- A statement that the person concerned will not work/not work while studying (with stamp duty) -(We provide)
- Financial guarantee letter from parent/sponsor (with stamp duty) - (we have the draft, you just need to fill in the information and sign) Statement letter of student filled by school.
- (This letter is used to state that the student is in fact getting education at the school)
- Parent's passport / sponsor's ID card
- Health certificate from doctor and Vaccine Card (Medical Check Up)
- Home address in Indonesia

APPLICANT REQUIREMENTS

- Copy of the Passport and minimum validity of 18
 months
- Copy of last 3 months' personal or parent's bank statements
- Current Visa (Onshore)
- Birth certificate & family book (in English or Indonesian sworn translation)
- ID photo
- Personal insurance
- Home address in Indonesia with Domicile letter from the Banjar (Onshore)
- Boarding pass from the flight to Indonesia (Offshore)
- Statement letter (We provide)



DOCUMENTS DO'S & DONT'S

To avoid delay in your Visa Application, please apply the rules below to any documents you send to us.

1) SCAN YOUR DOCUMENT

(PASSPORT, ID CARD, FAMILY BOOK, BIRTH CERTIFICATE...)

ENSURE YOU SEND US A CLEAN AND READABLE SCAN OF YOUR DOCUMENT, DON'T JUST TAKE A PICTURE OF IT





2) SEND A PDF DOCUMENT

(BANK STATEMENT, VACCINE CERTIFICATE, INSURANCE...)

PLEASE DON'T SEND SCREENSHOTS, BUT SEND A READABLE AND CLEAN PDF DOCUMENT.





3) TAKE ID PHOTO WITH WHITE/RED BACKGROUND

MAKE SURE IT IS A CLEAN, GOOD-QUALITY PHOTO WITH THE RIGHT COLORED BACKGROUND.
