

### PT PMA SETUP AIRBNB BUSINESS GUIDE

1. Due diligence, which includes the following:

A. Check the certificate at the National Land Agency (BPN)

b. Check taxes, tax arrears, property and building taxes vs. Check spatial/zone compliance

Price: From IDR 1,500,000 Duration: 2-3 weeks

2. Check PBB to determine if the land is subject to a loan Price: From 750,000 IDR Delivery time: 7-10 working days

3. A simple rental agreement in English and Indonesian under the name PMA

Price: From 2,500,000 IDR Delivery time: 7-10 working days

4. Establish a PMA and register it on the plot or virtual address, depending on the zoning of the land Price: 33,000,000 IDR (+ 8,080,000 IDR for the virtual address) Delivery time: 10-30 working days

5. A lease deed in the name of PMA

Price: Depends on the transaction Deadline: 30 working days

6. A measurement/topography survey, if necessary

Price: The price depends on the size of the plot Duration: no estimate

7. A soil test before laying the building foundation, if necessary

Price: The price depends on the size of the plot Duration: no estimate

8. Obtain an ITR or advice on planning if necessary

Price: From 2,500,000 IDR Delivery time: 21 working days

9. Apply for a PBG building permit and start building if necessary

Price: From IDR 12,000,000 Duration: 8 months

10. An SLF use permit if necessary

Price: The price depends on the size of the plot Duration: 8 months

11. Apply for a Pondok Wisata license for Airbnb business (only applicable to premises, check if the owner already has it). At least 3 rooms are required in the building to obtain the permit.

Price: The price depends on the size of the plot Duration: 8 months

#### Recommended zoning:

- 1. R-2 High-density housing sub-zone of residential zone
- 2. R-3 Residential zone Medium density residential subzone
- 3. R-4 Low-density housing sub-zone of the residential zone
- 4. K-1 Commerce and Services Zone City-wide Commerce and Services Subzone
- 5. K-2 Trade and services zone Trade and services sub-zone Scale Urban zone Section
- 6. K-3 Commerce and services zone Subscale Commerce and services subzone for urban areas

#### Considerations to keep in mind

To obtain a Pondok Wisata license, the building must have at least 3 but not more than 5 rooms and be designed in a cottage or villa style.

Pondok Wisata license must be updated every 5 years

Time and cost estimates are approximate and may vary depending on various factors, such as land size and location, and complexity of the project.
