

# D1 MULTIPLE ENTRY TOURISM VISA

## DESCRIPTION

- Ideal for carrying out tourism-related activities, visiting family or friends
- This visa is valid for 60 days each time you enter Indonesia. After 60 days you must leave the country or extend it by 60 days. You must leave after 180 days.
- This visa is multi-entry, you can leave and re-enter as you wish.
- This visa does not allow you to work and receive money in Indonesia. You cannot sell goods or services with this visa.

1 year validity : IDR 6.500.000

2 years validity : IDR 9.500.000

5 years validity : IDR 20.000.000

14 working days (excluding weekends and holidays)

1 year validity : IDR 5.500.000

5 years validity : IDR 15.000.000

Extension 60 Days : IDR 1.900.000

## APPLICANT REQUIREMENTS

- Last 3 bank statements in PDF format (minimum of 2,000 USD at the end of the month)
- Photocopy of passport with a minimum validity of 12 months
- Identity photo (Selfie on a white background)
- Address in Indonesia
- CV

## OWN SPONSOR REQUIREMENTS

- The deed of the company, Akta
- SK Menkumham
- NIB Letterhead Stamp of the company
- Physical stamp
- Balinese ID card/ local KTP
- KTP Passport Director
- KKPR
- NPWP of the company
- Username and password for visa online if they have it If they don't have, add Bank Statement of the company (Min 10.000 USD)

## What is important to know

- This visa does not allow you to work or receive money in Indonesia. You cannot sell goods or services with this visa.
- We can convert this visa into a residence permit
- You must be sponsored by either an Indonesian company or our agency.
- Please inform us of your travel or exit plans to extend your visa on time.
- This visa can be valid for 1 year, 2 years or 5 years.
- You cannot stay more than 60 days at each entry unless you make a 60-day extension.
- There is no extension shorter or longer than 60 days.
- If you overstay your visa, the penalty is IDR 1 million per day per person
- If you want to get another visa, you will have to leave the country and apply for the new visa.
- You cannot sponsor your relatives with this visa, it is not a residence permit.
- Immigration reserves the right to change regulations at any time
- We cannot initiate the creation process if you are in Indonesia
