INDONESIA

C6- Social, Humanitarian Visa

DESCRIPTION

- For those who plan to stay in Indonesia for no more than 180 days.
- This visa allows you to come to Indonesia to participate in a social program, a humanitarian mission, participate in missions in an association
- Can be extended or converted to any other KITAS without leaving Indonesia.
- Single entry Visa. If you leave Indonesia, you will need to start the process for a new visa.
- This visa does not allow you to work and receive money in Indonesia
- You must be sponsored by either an Indonesian company or our agency.
- This visa is valid for a maximum of 180 days.

(process time 14 working days) : IDR 3,500,000

(process time 5 working days)

Sponsor Legal Legends: IDR 4,500,000

Own sponsor: IDR 4,000,000

Extension:

IDR 1.900.000 / extension / 60 days (maximum 2 extensions).

* to apply for visa extension, bring your original passport to one of our offices at least 10 working days before the visa expiration date



STEP 1:
Submit all documents to LLI for checking



STEP 2:
Invoice & Payment



STEP 3:
Submit to Immigration



STEP 4:
Wait for E-Visa to be issued



STEP 5:
E-Visa issued. 90 days to enter Bali.



STEP 6:
Extension to be done before the visa expires.

APPLICANT REQUIREMENTS

- Photocopy of your passport (minimum 12 months)
- Last 3 bank statements in PDF format (minimum 2000 USD at the end of the month)
- Airline ticket (outbound, you do not need the return)
- Identity photo (selfie on a white background with a t-shirt)
- Proof of registration or certificate as a participant in a social program.
- Address in Indonesia

OWN SPONSOR REQUIREMENTS

- The deed of the company, Akta
- SK Menkumham
- NIB Letterhead Stamp of the company
- Physical stamp
- Balinese ID card/ local KTP
- KTP Passport Director
- KKPR
- NPWP of the company
- Username and password for visa online if they have it If they don't have, add Bank Statement of the company (Min 10.000 USD)

What is important to know

- This visa does not allow you to work or receive money in Indonesia. You cannot sell goods or services with this visa.
- This visa is only for Social Program/ Humanitarian/ Tourism
- You must be sponsored by either an Indonesian company or our agency.
- Please inform us of your travel or exit plans to extend your visa in time.
- We can help you get this visa faster if you wish
- If you currently have a VOA it is not possible to convert it to a C6 visa.
- The visa is a single entry visa; leaving the country will void it.
- Extensions must be initiated 10 days before the visa expires, only 60-day extensions
- If you overstay your visa, the penalty is IDR 1 million per day per person
- Immigration reserves the right to change regulations at any time
