DESCRIPTION

Investor KITAS is for those who invest and/or are shareholders in a company.

1 YEAR

The KITAS is valid for 5 years

Each year the visa will need to be extended. There is no need to leave the country to arrange the yearly extensions.

2 YEARS

The KITAS is valid for 6 years

Every 2 years the visa will need to be extended. There is no need to leave the country to arrange the extensions.

APPLICANT REQUIREMENTS

- Minimum age of 18 years old
- Copy of the Passport (Minimum validity of 18 months for 1-Year KITAS & 32 months for 2-Year KITAS)
- ID Photo
- Copy of last 3 months' Bank Account Statement
- Statement letter (We provide)
- Home Address with Domicile letter from your Banjar (Onshore)
- Existing e-Visa (Onshore)
- Current Visa (Onshore)
- Boarding Pass (Offshore)
- SKTT (Surat Keterangan Tempat Tinggal) (Extension)
- 3 last bank statements from PT PMA with 10,000 dollars

SPONSOR REQUIREMENTS

- Deed of the company/Akta
- SK Menkeh
- NIB Berbasis Resiko including PKKPR (Approval of the Suitability of Space Utilization Activities)
- Lease agreement from the property of the company registered
- Letterhead
- Stamp of the company (Physical stamp)
- Balinese ID Card (It can be your friend's/ company's employees)
- Copy KTP/Passport Director & Commissioner
- SKTU
- NPWP of company
- Username & password for visa online
- If they don't have, add Bank Statement of the company (Min 10.000 USD)

1) SCAN YOUR DOCUMENT

(PASSPORT, ID CARD, FAMILY BOOK, BIRTH CERTIFICATE...)

ENSURE YOU SEND US A CLEAN AND READABLE SCAN OF YOUR DOCUMENT, DON'T JUST TAKE A PICTURE OF IT.



2) SEND A PDF DOCUMENT

(BANK STATEMENT, VACCINE CERTIFICATE, INSURANCE...)

PLEASE DON'T SEND SCREENSHOTS, BUT SEND A READABLE AND CLEAN PDF DOCUMENT.



3) TAKE ID PHOTO WITH WHITE/RED BACKGROUND

MAKE SURE IT IS A CLEAN, GOOD-QUALITY PHOTO WITH THE RIGHT COLORED BACKGROUND.
