

INVESTOR KITAS

DESCRIPTION

- The KITAS Investor is intended for those who invest and/or are shareholders of an Indonesian company.
- This residence permit allows you to lead, manage your teams, make decisions, sign contracts, recruit.
- The KITAS is valid for 2 years. It can be valid for a maximum of 6 years.
- It allows you to leave the country as you wish.
- It is necessary to stay in Indonesia during the extension period (30 days)
- You can apply for the Kitas from abroad (OFFSHORE) or from Indonesia (ONSHORE)
- This residence permit allows you to sponsor your family with a Family Kitas

PRICING

OFFSHORE (From abroad)
2 years validity: IDR 19,500,000

ONSHORE (From Indonesia)
1 year validity: IDR 17,000,000
2 years validity: IDR 23,000,000

Investor Kitas Extension: (30 Days Process)

1 Year: IDR 13,500,000 (Possible to do 5 extensions)
2 Years: IDR 21,500,000 (Possible to do 2 extensions)

Exit Permit Only (EPO): This process is mandatory if you want to stop your Kitas or apply for another residence permit. The price starts from IDR 1,000,000.

Invoice & Payment



STEP 3:
Submit to Jakarta to make E-Visa.



STEP 4:
Wait for E-Visa to be issued



STEP 5:
Offshore can arrive to Indonesia.

KITAS is done

APPLICANT REQUIREMENTS

- Copy of Passport (Minimum validity of 18 months for 1 year KITAS & 32 months for 2 year KITAS)
- ID Photo (Selfie on a white background)
- Last 3 personal bank statements with a minimum of 2000 USD at the end of the month in PDF format (Name and date)
- Address in Indonesia
- Last bank statement from PT PMA with 10,000 dollars
- Current electronic visa + Stamp (Onshore)
- Flight ticket to arrive in Indonesia + Boarding Pass (Offshore)
- Balinese Identity Card (KTP)

DOCUMENTS OF YOUR PT PMA

- The deed of the company, Akta, SK Menkumham, NIB and Letterhead
- Physical stamp, Balinese ID card/ local KTP
- KTP Passport Director
- KKPR, NPWP of the company
- Username and password for visa online if they have it If they don't have, add Bank Statement of the company (Min 10.000 USD)

WHAT YOU NEED TO KNOW

- The Investor Kitas allows you to lead, manage, sign contracts, recruit. It allows you to be present within the teams and to justify your presence to immigration.
- The Investor Kitas is sponsored by your PT PMA.
- It allows you to reduce taxes on dividends and benefit from Indonesian taxes because you are an Indonesian tax resident.
- It allows you to enter and leave the territory as you wish.
- This residence permit can be valid for 6 years.
- It allows you to sponsor your loved ones with the Family Kitas
- We can apply for this residence permit if you are outside Indonesia or in Indonesia.
- If you exceed the validity date of your residence permit, the penalty is 1 million IDR per day and per person
- Immigration reserves the right to change the regulations at any time
- Please inform us of your travel or exit plans to extend your Kitas on time.
- We can help you obtain this Kitas faster.
- You must have 10 billions IDR in PT PMA capital to apply for the Investor Kitas.
- You must be over 18 years old.
