



# FAMILY KITAS

E31A-E31B-E31E

## DESCRIPTION

- This Kitas is for people who are dependent on a relative with a residence permit or a relative with Indonesian nationality.
- The KITAS is valid for 1 year, it is possible to make 5 extensions of 1 year. This residence permit can be valid for a maximum of 6 years.
- It allows you to enter and leave the territory as you wish.
- It is necessary to stay in Indonesia during the extension period (30 days)
- You can apply for the Kitas from abroad (OFFSHORE) or from Indonesia (ONSHORE)
- The maximum age for children to obtain this Kitas is 17 years old.

## PRICE

### 1 YEAR :

OFFSHORE : DR 12,500,000 /process 7 working days

ONSHORE : IDR 15,500,000 /process 30 days

Extension 1 year : IDR 10,000,000 (30 days)

### 2 YEARS :

OFFSHORE : IDR 17,500,000 /process 7 working days

ONSHORE : DR 20,000,000 /process 30 days

Extension 2 years : IDR 19,000,000 (30 days)

Exit Permit Only (EPO): This is mandatory if you want to stop your Kitas or apply for another residence permit. The price starts from IDR 1,000,000.



**STEP 1:** Submit all documents to LLI



**STEP 2:** Invoice and Payment



**STEP 3:** Sending documents to immigration.



**STEP 4:** Waiting for the e-visa to be issued.



**STEP 5:** Offshore applicants can arrive in Indonesia.



**STEP 6:** KITAS is done.

## APPLICANT'S DOCUMENTS

- 3 latest bank statements of the sponsor (spouse/husband) with a minimum of 2000 USD in PDF format.
- Identity Photo (Selfie on a white background)
- Copy of passport with a minimum validity of 18 months
- Copy of marriage certificate or family record book (English)
- Insurance with name in PDF format
- Current visa (ONSHORE)
- Boarding pass (OFFSHORE)

• For children:  
Copy of birth certificate (must be translated into English)

## SPONSOR DOCUMENTS

- The deed of the company, Akta, SK Menkumham, NIB and Letterhead
- Physical stamp, Balinese ID card/ local KTP
- KTP Passport Director
- KKPR, NPWP of the company
- Username and password for visa online if they have it. If they don't have, add Bank Statement of the company (Min 10.000 USD)

## Sponsor: **INDONESIAN SPOUSE**

- Copy of spouse's "KTP" ID card
- Copy of spouse's "Kartu Keluarga" Family Book Copy of spouse's birth certificate
- Last 3 bank statements of spouse with 2000 USD.
- Copy of Marriage Certificate / Marriage Book

## WHAT YOU NEED TO KNOW

- This Kitas does not allow you to work and receive money in Indonesia. You cannot sell goods or services.
- We can convert a visa to a Family Kitas
- You must be sponsored by either a spouse with a Kitas or an Indonesian spouse.
- Please inform us of your travel or exit plans to extend your Kitas on time.
- The Kitas is a multiple entry. You can enter and exit the country as you wish.
- If you have a Family Kitas sponsored by an Indonesian spouse, you can apply for a work permit.
- Extensions must be initiated 1 month before the end of the validity period.
- The validity period of your Family Kitas will be the same as your spouse's Kitas.
- It is not possible to apply for a 2-year Family Kitas if your sponsor's kitas is only valid for 1 year.
- If you overstay your residence permit, the penalty is IDR 1 million per day per person
- Immigration reserves the right to change regulations at any time
- We cannot initiate the OFFSHORE creation process if you are in Indonesia.
